1. Batteries must be removed/disconnected & propane tanks are not permitted in the storage building.
2. Floor must be protected from oil drippings.
3. The Binbrook Agricultural Society will not accept any responsibility for injury or damage, or for the loss or theft of any personal effects or the vehicle of the occupant. The Occupant shall indemnify and Hold harmless the Binbrook Agricultural society, their members and employees from and against all losses, costs and damages arising out of use of the facility and property of the Binbrook Agricultural Hall. Occupant assumes all risk for loss or damage.
4. Occupant understands that the Binbrook Agricultural Society does not, and will not, insure Occupant's property. Occupant has the sole responsibility for insuring its property and will ensure to maintain comprehensive insurance on the vehicle through the term of the agreement.
5. Occupant will store only property that is owned by the Occupant and will not store property claimed by another person or in which a person has an interest.
6. This agreement replaces all other oral or written agreements between the owner and the Occupant.
7. Payment is due in full prior to placing the vehicle in storage.
8. All vehicles must be removed on or before Saturday April 27th, 2019.
